



ATHLETE REGISTRATION WAIVER

In consideration of Crossfit Infinite allowing me to participate, I acknowledge, understand and I am aware that: I have voluntarily chosen to participate in the Fittest Mum competition provided by One Drop Ltd, trading as “Crossfit Infinite”. I understand there are inherent risks in all aspects of physical training and I acknowledge that I am aware of the possible strenuous nature of the competition and the potential for undesirable physiological results including, but not limited to, abnormal blood pressure, muscle soreness, fainting, heart attack and/or death.

I understand that the competition may involve weight lifting, gymnastic movements, strenuous body weight exercises and other high exertion activities, and that I am not obligated to perform nor participate in any activity that I do not wish to do, and that it is my right to refuse such participation at any time during the competition. I understand that should I feel light-headed, faint, dizzy,

nauseated, or experience pain or discomfort, I am to stop the activity and inform my judge. I give Crossfit Infinite in association with Fittest Mum and the competition staff of the venue my permission to seek emergency medical services for me should I become injured or ill with the understanding that I am responsible for any expenses incurred.

I agree to WAIVE ANY AND ALL CLAIMS that I have or may have in the future against Fittest Mum, Crossfit Infinite, Fit Mum and its directors, officers, employees, agents, volunteers and independent contractors (all of whom are hereinafter collectively referred to as “the Releasees”). I agree to RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of my participation in the Fittest Mum competition provided by Crossfit Infinite, due to any cause whatsoever including negligence, breach of contract, or breach of any statutory or other duty of care. I agree to HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to the property of, or personal injury to, any third party, resulting from my participation in the Fittest Mum competition, activity or service provided by the releasees.

This agreement shall be binding upon me, my successors, representatives, heirs, executors, assigns, or transferees. If any portion of this agreement is held invalid, I agree that the remainder of the agreement shall remain in full legal force and effect.

If I am signing on behalf of a minor child, I also give full permission for any person connected with Fittest Mum or Crossfit Infinite to administer first aid deemed necessary, and in case of serious illness or injury, I give permission to call for medical and or surgical care for the child and to transport the child to a medical facility deemed necessary for the wellbeing of the child.

Use of picture(s)/film/likeness: I agree to allow Fittest Mum, Fit Mum, Crossfit Infinite, its agents, officers, principals, employees and volunteers to use picture(s), film and/or likeness of me for advertising purposes. In the event I choose not to allow the use of the same for said purpose, I agree that I must inform Crossfit Infinite , Fit Mum of this in writing before the commencement of the Fittest Mum competition.

I accept financial responsibility for any injury that I may cause either to myself or to others. Should the above mentioned parties, or anyone acting on their behalf, be required to incur attorney’s fees and costs to enforce this agreement, I will reimburse them for such fees and costs.

Refund: No refunds will be given under whatsoever reason(s) and/also including any form of Force Majeure.

I HAVE READ AND UNDERSTOOD THIS AGREEMENT AND I AM AWARE THAT BY SIGNING (clicking agree) THIS “INFORMED CONSENT FORM” I AM WAIVING CERTAIN LEGAL RIGHTS (INCLUDING THE RIGHT TO SUE) WHICH I OR MY HEIRS, NEXT OF KIN,

EXECUTOR, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES. ANY QUESTIONS I HAD WERE ANSWERED TO MY FULL SATISFACTION.
