REGISTRATION:

If the second date cannot go ahead Metcon will refund all entry fees minus any costs incurred for the cancelled event and preparations

PRIZES:

Should the team fail to comply or agree to the terms and conditions or receiving competition prizes, they will forfeit their prize and this will be allocated to the next runner up.
